






### It all started...

### Law 93/2023

- ISPs are ordered to block FQDNs and IP Addresses as told by authorities - IP Addresses where the illegal activity is the sole activity\* for which the IP is used

The blocks need to happen in 30 minutes from the moment data is published

Copyright holders are the ones in charge of communicating these addresses

AGCOM is in charge of providing a platform to communicate these blocks





## The platform

- Donated to AGCOM by SP Tech
  - A branch of Studio Previti, a legal counselling organisation


Initially built to support 18k FQDN (law-imposed limit) 

router configs

• Specifications changed many times, leading to initial chaos



ISPs needed to build their own solution to query the platform and create their own





# The ticketing system

- Copyright holders have access to create "tickets"
  - They contain IP Addresses and/or FQDNs


- ISPs query the system, download the latest tickets and apply the filtering
  - This needs to be done in 30 minutes \_







## Some bumps in the road

 Less than a month after "getting into service" (1st February 2024)

 An IP address from Cloudflare made it into the list...

 Tens of thousands of websites unreachable for around 40 hours from Italy



In a few months, about 17k other addresses had the same fate...





# New law/regulation (October 2024)

- IP addresses need to be used predominantly for illegal activities
  - Not the sole activity...
  - There is an official unblock concept now
- VPN and DNS providers are also subject to applying filtering
  - Independently of where they are located

- contact the police
  - Otherwise they risk 1 year in jail



  - As a FQDN (drive.usercontent.google.com)


Speculation is that some lists of streaming sites were hosted there

• Block was removed at about 00:20 on 20th of October

## Other small bumps in the road...


- An ISP's block notification page has also made it to the list of blocked entities
  - We like to call it "inception blocking"

The government is now trying to force them to join a working group

# A shiny future ahead...


• There is apparently a new platform in the works...

- The number of RIPE Atlas probes has been declining
  - If your probe is used to test accessibility of blocked resources, you might be charged...

Operators are now left with more and more questions






